Chair Franchi advised that the Committee was reconvening at 10:42 a.m., and recommended that because the information was so complex, that he would like to see the Minutes from this meeting in the next regular Board Meeting Packet, so that the full Board can read all of the issues that came up. Discussion ensued. Karen Miller, Administrative Group representative, addressed the Committee, advising that the Group has expressed their opinions regarding the part-time positions, and advised that she hoped the Committee understood how important the part-time positions are to the organization and how much the hours are needed; advised that the Group supported the receptionist position – it needs to be manned or not manned, because going back and for this difficult for both herself and Katie; advised that the Group supports the part-time inspector position; advised that as a Prevention staff person – any time an inspector goes out and it is in the fee schedule, it is billable; advised that the Group is in support of the Fire Chief and hope that the Board will go ahead with the increased hours for the part-time employees. Chief Hall advised that staff was recommending Option 2 in the report; advised that it is what he and the staff believe would accommodate the workload today and into the future, without "going over the top"; advised that he appreciate the Committee's thoughts, but analyzing the current workload and the current duties, but that he believes that based on Option 2, would suffice for the near future – he advised he couldn't say what would happen in three to five years as far as the increased workload; advised that Option 1 moves everyone up to 40 hours, and that would cost the District \$33,000 more – but that is \$33,000 that could be used for other things – that are not any more important – but we believe it is not needed. Discussion ensued. Erin Schaffer addressed the Committee, advising that if she needs to work longer hours to get the job done, she always stays; advised that she has always adjusted her schedule, i.e. if the County was closed; advised that she works very diligently – she even eats at her desk because she has the flexibility to do so: she advised that right now she can't go full-time - more than likely she can in the future; advised that she is frustrated because she has had to justify her 30 hours and now the Committee is suggesting it should be a full-time position. Discussion ensued. Chief Hall reiterated that he and staff are not asking for more employees in the administrative section of Central Fire; advised that the receptionist position has been a nonfunded position but has never been taken off the books; and,

advised that Ms. Fench advised that the receptionist position was a full-time position – and not that many years ago there was someone staffing that position. Discussion ensued regarding the receptionist position. Chief Hall advised that if the recommendation from the full Board is not to not fill the receptionist position, then it will be vacant, and he advised that he was strongly opposed to pulling people from other positions to do receptionist duties; advised that he believes that the additional hours given to the other positions are critical to accomplishing cross-training and to complete their workloads. Ms. Fench suggested that if the Committee and the Board decided to make a position a 40 hour position and the person working the position is unable to work the 40 hours, the District could allow the employee to work less hours, and then at some point if the employee was able to work the 40 hours in the future they could do that. Discussion ensued.

The Committee was in consensus to recommend to the Board to go forward with Option 2.
